

The Alien Abduction Files: A Christian Perspective

Introduction

As I read your book *The Alien Abduction Files (AAF)*, I could sense your sincerity and zeal to expose truth, wherever it may be found. I sensed a certain bridled frustration at the general public who remain asleep to the various facts conveyed, rightly so. I first want to say that I believe your Experiencers in every way. I believe they witnessed what they expressed, and I trust their accounts. The difference however, lies in our interpretation of their experiences. I was moved to respond to many sections of your book according to my own studies as a born-again Christian. I realize that the 'Alternatives' chapter in AAF briefly discusses the Christian perspective – a sort of summary view. My intention however, is to explore the various revealed facts presented in AAF at a granular level, and see how they compare with a) Scriptures from The Judeo/Christian Bible, b) books on eschatology (end-time studies), and c) other Christian books and resources. It is from this worldview, I would like to offer my response to your very well-written and comprehensive book.

Additionally, my real passion is for you to consider a link that I have included in this response which highlights an amazing organization which can show you and those Experiencers in your sphere of influence how to stop an alien abduction experience, if you so choose. I know Denise wrote that she considers her abductions worth having because of the wisdom and understanding that comes along with her experiences. I can appreciate that motive; I am driven that way myself. Indeed, the Biblical book of Proverbs says, *"The beginning of wisdom is this: Get wisdom. Though it cost all you have, get understanding. Cherish her, and she will exalt you; embrace her, and she will honor you. She will give you a garland to grace your head and present you with a glorious crown. Listen, my son, accept what I say, and the years of your life will be many."* (Proverbs 4:7-8) I would ask you to consider however that not all wisdom is truly wise, in spite of its alleged "extra-terrestrial" or other-worldly origins. Could it be that the "wisdom" from alien beings, differs in essence from that which Solomon had encouraged his son almost three thousand years ago? And if so, which wisdom should we heed? Could both sources of 'wisdom' be correct, and what is the standard? Could the ancient Bible have anything to say about the alien abduction experience? My prayer is that you will be open to consider the alien phenomena from a Biblical world-view.

For your convenience, I have included a Table of Contents for quickly maneuvering themes presented within The Alien Abduction Files (AAF).

Note: I have also included a sort of Bibliography at the end called "References". Throughout the document, I conclude referenced text with a three-letter code and page number; the bibliographical information can be further explored under References using the three-letter code.

A: Prosaic Explanation Missing In Action

Thus far, no one has offered a credible prosaic explanation for alien abduction, especially when the abductee is of sound mind, has conscience, continuous recall of the event, corroborating witnesses, and missing time that defies explanation. (AAF pg. 129)

Well said. I don't intend to offer a "prosaic" explanation in the sense of "lifeless" interpretations for very real, very living entities. However, I believe the Bible itself is the key that unlocks this enigmatic mystery of our day.

I would like to begin with the Roman Catholic interpretations offered in the last few pages of your book. You may wonder why my 'Christian' views would be different than Catholic doctrine; are they not the same? Yes, and no. We will explore whether or not the doctrines of modern Catholic and Jesuit clergy are in line with their tradition, and more importantly, with the Scriptures which they carry and regard as the testament to their faith.

Have the core beliefs of the Roman Catholic changed over the years? Could these changes offer an illuminating backdrop to the Vatican's official position regarding alien phenomena? We will explore these questions in the next section.

B: Modern Roman Catholicism - Perspectives

The Roman Catholic Church has offered an opinion on extraterrestrial encounters that differs from the Fundamentalist Christian point of view. The late Monsignor Corrado Balducci, a demonologist and priest close to Pope John Paul II, looking into extraterrestrial encounters spoke about alien contact. He emphasized that ET contact is not demonic or related to entity attachment, explaining that we must view extraterrestrials as part of God's creation – not angels or devils....

Father Jose Funes, Director [of] the Vatican Observatory, named to his position by Pope Benedict XVI, stated in 2008 that extraterrestrial beings should be considered a part of God's creation. Just as God created life on earth, he said, he may have created multiple forms of life throughout the universe that might be similar to humans, but different in many ways. 'This is not in contrast with the faith, because we cannot place limits on the creative freedom of God...' (AAF pp. 226-7)

To address these comments, I will present three arguments; one which highlights the internal 'politics', if you will, within the Catholic Church itself. The other two arguments will be in the form of two very interesting prophecies. The first prophecy we will explore is purported to be from an Irish Catholic named St. Malachy in the eleventh century, and the other prophetic text is from the Bible itself – in the book of "Revelation", or "Apocalypse" as it is named within the Catholic Bible.

1. Vatican Council II

In 1965, after a watershed conference referred to as “Second Vatican Council”, the official doctrine of the Catholic Church drastically changed from its centuries-long doctrinal views. We will see that the depth and significance of their momentous change will pave the way to Rome’s position on many ideas that were in former times considered dangerous heresies. And ultimately, our study will illuminate the reasoning behind Vatican’s official position on aliens and so-called “extra-terrestrial” beings.

Catholic doctrine has always acknowledged the exclusivist words of Jesus who said *“I am the way and the truth and the life. No one comes to the Father except through me.”* (John 14:6) However, Vatican Council II broke tradition, and their doctrine has been altered to include other religious pathways to God. Consider the writing of Malachi Martin who was a former Jesuit, eminent theologian, expert on the Catholic Church, and professor at the Vatican’s Pontifical Biblical Institute. In this passage, Martin discusses Pedro Arrupe, formerly one of the highest ranking Jesuit priests called “Father General” sometimes referred to as the “Black Pope” due to Jesuit signature black attire. Arrupe was Father General during the paradigm-shifting Second Vatican Council which irrevocably altered the essence of Catholicism:

In all his enthusiasm for ‘enculturation’ and the adaptation of the Christian message to Indian subcultures, Arrupe seems never to have perceived how the Hinduization of the Catholic Mass was eviscerating that ceremony of its essential meaning....For instance, in the ‘Indian Rite’ used by Catholics in Poona, genuflection before the Eucharist has been abolished in favor of ‘anjali haste’, the profound bow Hindus concede to minor gods. Prostration (shastangam or ashtangam) is reserved for the Great God, but not given to Jesus Christ....In spite of a specific veto from the Vatican on the subject, the mantra OM is used in the ‘Indian Rite’. OM in Hindu theology is the Hindu god Krishna. Its use in Hindu ears means worship of Krishna. (JES pg. 411)

This doctrine of “enculturation” which assimilates other religions into Christianity is sometimes referred to as the “ecumenical” or “inter-faith” movement. The Catholic Church is clearly a forerunner in this worldwide movement:

While the efforts of the World Council of Churches have been paramount in bringing the liberal Protestant denominations together, no event would give greater momentum to the ecumenical movement than Vatican II. The *Catholic Encyclopedia* proudly boasts, “The greatest religious event of the twentieth century, whose teachings and clarifications have yet to reach their full impact, was the twenty-first Ecumenical Council, called Vatican II or the Second Vatican Council.

Vatican II, which opened on October 11, 1962 at St. Peter’s Basilica in Rome, added fuel to the growing ecumenical movement and helped pave the way for the acceptance of interfaithism. Pope John XXIII presided over the Council’s proceedings. According to M. Basil Pennington, a prominent Catholic priest, the Council urged “all Christians...to act

positively to preserve and even promote all that is good in other religions: Hinduism, Buddhism, and other world religions. (NWR, page 208)

The denial of Christianity's exclusivity is by far the most damning deviation from Scriptural truths, rendering their views a "new gospel" for which the Apostle Paul used his harshest rebuke: "even if we or an angel from heaven should preach a gospel other than the one we preached to you, let them be under God's curse!" (Galatians 1:8) While the new gospel is the greatest affront to Biblical Christianity, it is very easy to discern. Another deviation occurred during Vatican II which is more subtle and insidious; the Catholic agenda now includes worldwide Communist activism. Often Jesuit priests held political office in Communist countries, and/or fought alongside Communist soldiers against governments and peoples of opposing views. Martin explains that Jesuitism in various parts of the world adopt the ideology of their fellow Jesuit, Arthur F. McGovern. Martin explains:

McGovern sees in Jesus, as portrayed in St. Luke's Gospel, a paragon of revolution. St. Luke's is "a social Gospel," he says, quoting Jesus in support of his cause: "I have come to preach the good news to the poor, to set the downtrodden free, to redeem captives."

"See," McGovern adds, "how many times Jesus speaks about poverty; identifies with poor people; criticizes people who lay burdens on the poor." Clearly, therefore, Jesus acknowledged the "class struggle" and endorsed the "revolution".

Consciously, or unconsciously, like most modern Jesuits and many Catholic activists, McGovern has effectively laid aside fourteen hundred years of rich Catholic, authentically Christian interpretation of the Bible. He has reinterpreted the Gospel and the salvific mission of the Son of God in an economic sense, a this-worldly sense, a nonsupernatural sense, an un-Catholic sense. (JES pg. 16)

After teaching and endorsing doctrines so opposed to the words of Jesus, can this group of people legitimately call themselves followers of Christ, or Christians? I believe this question is being asked by Malachi Martin himself within his many books dedicated to exposing the unfortunate fallen nature of his own church.

But what do these doctrinal deviations have to do with aliens and AAF? It turns out, quite a bit. Consider this quote from *Exo-Vaticana* in which Jesuit Priest and Vatican Astronomer Father Giuseppe Tanzella-Nitti describes the integration of the Christian faith with extra-terrestrials who will be coming upon the earth:

Giuseppe states this would not immediately oblige the Christian "to renounce his own faith in God simply on the basis of the reception of new, unexpected information of a religious character from extraterrestrial civilizations," but that..."once the trustworthiness of the information has been verified," the believer would have to "reconcile the new information with the truth that he or she already knows and believes on the basis of the revelation of the One and Triune God, conducting a re-reading [of the Gospel] inclusive of the new data." (EXO pp. 23-4)

So the Christian “gospel” or good news of salvation through the sacrificial atoning blood of Jesus Christ is no longer Christianity’s core message. Now the gospel and its meaning are subject to change, it will need to conform to our “new” scientific knowledge. I use quotes around “new” because as we will see, the so-called extra-terrestrial is anything but new. We will visit the fallen-angel offspring in Genesis 6 and its legacy throughout the ancient world. We will also examine enumerable cultural demonic phenomena which have an uncanny resemblance to today’s “extraterrestrial”. So the Jesuits want to shamelessly rewrite the ancient Scriptures. As an interesting side-note, the Jesuit astronomical team in Arizona uses an instrument with a rather unconventional name as they look for extraterrestrial life in outer space:

L.U.C.I.F.E.R., which stands for “Large Binocular Telescope Near-Infrared Utility with Camera and Integral Field Unit for Extragalactic Research,” is a chilled instrument attached to a telescope in Arizona. And yes, it’s named for the Devil whose name itself means “morning star” [and which] happens to be right next to the Vatican Observatory on Mt. Graham in Tucson. (EXO pg. 9)

LUCIFER is German-built and co-owned and funded by NASA and the Vatican (Exo-Vaticana page 25). Tom Horn and Chris Putnam, co-authors of *Exo-Vaticana*, were given a tour of the Vatican Observatory in Arizona on Mt. Graham. They describe what the Vatican astronomers are searching for in deep space:

...the Jesuit father on duty that day (whom we got on film)...told us that among the most important research occurring with the site’s Vatican astronomers is the search for extrasolar planets and advanced alien intelligence....we walked up the gravel road from VATT [Vatican Advanced Technology Telescope] to LBT [Large Binocular Telescope], where we spent most of the day with a systems engineer who...took us to all seven levels of that mighty machine – pointing out the LUCIFER device (which he lovingly referred to as “Lucy” several times and elsewhere “Lucifer”)....(EXO pp. 14-15)

Clearly the Catholic Church has sponsored and promoted alien awareness, and I believe they will continue to play a pivotal role in bringing about the alien agenda in the future, even so far as to include the “alien gospel” within their ecumenical list of “Christian” doctrines. Has this great deviation from traditional Roman Catholicism taken the world by surprise, or were there any “hints” of its eventual emergence?

2. St. Malachy: The Prophecy of the Popes

Before delving into see what the Bible has to say, we will first explore a small collection of well-known Catholic prophetic writings commonly referred to as St. Malachy’s “Prophecy of the Popes”. St. Malachy was born in 1094 in Northern Ireland. He was well-respected in the Church, and he soon met with favor from his pope, Innocent II who bestowed upon him positions in the upper hierarchy of the Catholic Church.

As the legend goes, Malachy experienced what is today considered a famous vision commonly called “The Prophecy of the Popes.” The prophecy is a list of Latin verses

predicting each of the Roman Catholic popes from Pope Celestine II to the final pope “Peter the Roman”.... (PET pg. 14)

There is a certain controversy around these prophecies, however. There appears to be evidence of tampering of early prophecies, as well there seems to be question as to whether “St. Malachy” is in fact the author of the prophecies at all.

Thomas Horn and Chris Putnam have completed an outstanding work delving into the controversy giving dates, evidence and scanned documents from historic archives in their well-researched book “Petrus Romanus: The Final Pope is Here”. But for the scope of this writing, I will include only a summary conclusion from their aforementioned book:

The exciting news is that the Prophecy of the Popes, although tainted, is still a genuine prophecy. Despite the superficial insincerity detectable in the first section of “prophecies”, the post publication predictions show astonishing fulfillments. We have no critical analysis to explain away the sometimes jaw-dropping, post 1595 fulfillments [year in which the prophecies were published which provides a watershed after which no further tampering or forgeries could be perpetrated against the text without detection]. (PET pg. 16)

To give an example of a fulfilled prophecy, consider Pope John Paul II. His Malachian prophecy was “De labore solis” which means “From the labor of the sun”. How was this prophecy fulfilled?

The motto is also said to possibly mean “eclipse of the sun,” “pregnancy of the sun,” or “travails of the sun”. John Paul II was born May 18, 1920, during a partial solar eclipse over the Indian ocean. He was buried on April 8, 2005, during a rare “hybrid” eclipse over South America and the Pacific. We commend you to follow the footnoted links as we verified the eclipses at NASA. This is one fulfillment that is clearly beyond human control. (PET pg. 54)

But what does all of this have to do with the Roman Catholic Church and aliens? The translated text for Malachy’s “final pope” seems to indicate that he and the people will be judged by the same God they professedly serve:

In the Final persecution of the Holy Roman Church there will reign Peter the Roman, who will feed his flock among many tribulations; after which the seven-hilled city will be destroyed and the dreadful Judge will judge the people. (MAL pg. 96)

The current pope in power at the time of this writing (May 5, 2014) is in fact the final pope according to the chronology within the “Prophecy of the Popes”. And interestingly, he is also a Jesuit.

3. Revelation: The Woman on Seven Hills

So we looked at an extra-biblical reference, but does the Bible have anything to say about the Vatican's paradigm shift against tradition, and their new doctrinal positions after Vatican Council II? I believe it has much to say indeed.

Scripture refers to an "end-time" period wherein there will arise an "Anti-Christ" character who will take control of the entire world, and seek to be worshipped even within the new temple which will be rebuilt in Jerusalem on the Temple Mount. During the first century, the early church errantly believed that the Anti-Christ had already come in their own generation, however the Apostle Paul had these words of correction for the church at that time:

*Let no one deceive you by any means; for that Day will not come unless the **falling away** comes first, and the man of sin is revealed, the son of perdition [Anti-Christ], who opposes and exalts himself above all that is called God or that is worshiped, so that he sits as God in the temple of God, showing himself that he is God. (2 Thessalonians 2:3-4, emphasis mine)*

The Greek word which is translated here as "falling away" is "apostasia", and it means to "depart from" or "go away". This is where we get the English word "apostasy". So right before the coming of Anti-Christ, there will be an apostasy where Christians will fall away from their faith. A Biblical apostasy can only happen to those who believe the Bible, by definition; so these are people who once believed, but have "fallen away" from Christ.

Even still, are there any other Biblical clues that the Catholic Church is part of the "apostasia" Paul refers to in 2 Thessalonians? Consider the following Scriptures in the apocalyptic "end-time" book of Revelation:

"Come, I will show you the punishment of the great prostitute, who sits by many waters. With her the kings of the earth committed adultery, and the inhabitants of the earth were intoxicated with the wine of her adulteries."

Then the angel carried me away in the Spirit into a wilderness. There I saw a woman sitting on a scarlet beast that was covered with blasphemous names and had seven heads and ten horns. The woman was dressed in purple and scarlet, and was glittering with gold, precious stones and pearls. She held a golden cup in her hand, filled with abominable things and the filth of her adulteries. The name written on her forehead was a mystery:

*Babylon the Great
The mother of prostitutes
and of the abominations of the earth.*

I saw that the woman was drunk with the blood of God's holy people, the blood of those who bore testimony to Jesus.

When I saw her, I was greatly astonished. Then the angel said to me: "Why are you astonished? I will explain to you the mystery of the woman and of the beast she rides, which has the seven heads and ten

horns. The beast, which you saw, once was, now is not, and yet will come up out of the Abyss and go to its destruction. The inhabitants of the earth whose names have not been written in the book of life from the creation of the world will be astonished when they see the beast, because it once was, now is not, and yet will come.

“This calls for a mind with wisdom. The seven heads are seven hills on which the woman sits... They have one purpose and will give their power and authority to the beast. They will wage war against the Lamb, but the Lamb will triumph over them because he is Lord of lords and King of kings—and with him will be his called, chosen and faithful followers.”

Then the angel said to me, “The waters you saw, where the prostitute sits, are peoples, multitudes, nations and languages....The woman you saw is the great city that rules over the kings of the earth.”
(Revelation 17: 1-18 emphasis mine)

But what does all this mean? This must be just symbolic – how would anyone have the audacity to apply this Scripture to the Holy Roman Catholic Church which is the most recognized and ancient form of Christianity in the world? These are good questions, so let’s walk soberly and responsibly as we consider the Scriptures in Revelation 17. The accusation warrants very good reason – even ‘proof’ to make a valid connection between Revelation 17 and the Roman Catholic Church.

The “woman” is often used to represent God’s people. In the Old Testament, God married the nation of Israel, and became furious when she committed adultery against Him by worshipping other perceived gods. In the New Testament, the church is called “the bride of Christ”. This theme is often played out in Scriptures, both old and new testaments. So the “harlot” or prostitute riding on the beast is likely referring to God’s people who have gone astray, and the description implies that she has committed adultery. Spiritual adultery can be defined by one word: Ecumenism. Ecumenism is actually defined as “the principle or aim of promoting unity among the world’s Christian Churches.” However, Ecumenism as defined by Catholicism suggests that “all religions” belong under the umbrella of Christianity. Every “faith” is included. This sounds very accommodating and tolerant. However, there is a proverb which says: *“There is a way which seems right to a man, but its end is the way of death.”* (Proverbs 14:12) While accommodating and tolerant, the newly defined ecumenism or inter-faith movement Biblically equates to spiritual adultery. And whether our generation is found in the Old or New Testament, God jealously guards His wife. The way to God is to come to Him the way He has prescribed by His prophets, and by His Messiah who fulfilled their prophecies. Moses speaking for the Lord declared, “For the life of the flesh is in the blood, and I have given it to you upon the altar to make an atonement for your souls; for it is the blood that maketh an atonement for the soul.” (Leviticus 17:11) So the precedent was set in Scripture that no man is forgiven from his sins outside of sacrificial blood atonement. Scripture declares there is no other way to God; His ways are definitive and exclusive. The “new gospel” of Catholicism denies the exclusivity for the atoning work of Jesus Christ ever since Vatican Council II, and they will lead you to believe there are many ways to gain God’s favor and grace. I will not go further into Revelation 17 by discussing the beast and its other imagery because it is out of scope to the purpose of my writing. But I will make a few more points about the various descriptions. First, the woman sits on “*seven hills*”. This is another strong correlation to Rome vis-a-vis the Vatican, as she is known throughout history as

the “city of seven hills”. Lastly, over the last two thousand years, certainly the Vatican with its Jesuit proxies have been associated with “*peoples, multitudes, nations and languages*” and who “*rules over the kings of the earth*”.

In summary, I would encourage you to consider all of these factors and take them to heart as you hear representatives of the Catholic hierarchy endorse and offer grand support for our new alien friends and “saviors” from outer space.

The “Alternatives” section also occurs at the very end of your book, but I would like to continue from there because it contains foundational doctrines that are mutually exclusive with Scripture. Either the ‘Alternatives’ are true, and the Bible is in error, or the Bible is true, and the ‘Alternatives’ are in error. I believe you will come to see at the very least, both doctrines cannot inherently be true.

C: Paul Hamden’s Alternative Explanation?

Paul Hamden, a medium, has addressed [the alternative hypothesis that a segment of the abduction experiencer population is being influenced by astral entities rather than extraterrestrial beings]. Mediumship has a reputation as being a product of the human imagination, but Paul’s messages from three groups of alleged ETs (Zetas, Pleiadian and Anunnaki), have attracted the attention of a Canadian scientist who is studying the validity of the information given through Paul. (AAF pg. 225)

While “mediumship” has become an acceptable part of our culture, the Torah (first five books of the Bible) condemns this practice outright. Consider the following Scriptures:

Do not turn to mediums or spiritists; do not seek them out to be defiled by them. I am the Lord your God. (Leviticus 19:31)

I will set my face against anyone who consults mediums and wizards instead of me and I will cut that person off from his people. So sanctify yourselves and be holy, for I am the Lord your God. You must obey all of my commandments, for I am the Lord who sanctifies you. (Leviticus 20:6-8)

A man or a woman who is a medium, or who has familiar spirits, shall surely be put to death; they shall stone them with stones. Their blood shall be upon them. (Leviticus 20:27)

When you enter the land the Lord your God is giving you, do not learn to imitate the detestable ways of the nations there. Let no one be found among you who sacrifices their son or daughter in the fire, who practices divination or sorcery, interprets omens, engages in witchcraft, or casts spells, or who is a medium or spiritist or who consults the dead. Anyone who does these things is detestable to the Lord; because of these same detestable practices the Lord your God will drive out those nations before you. You must be blameless before the Lord your God. (Deuteronomy 18:9-13)

God reasoned through his prophet Isaiah saying “...when they [wayward Israelites] say to you, “Seek those who are mediums and wizards, who whisper and mutter,” should not a people seek their God? ...To

the law and to the testimony! If they do not speak according to this word, it is because there is no light in them.” (Isaiah 8:19-20)

So right away, we see that these Biblical instructions put Mr. Hamden’s practices at odds with the God of the Bible. Let’s continue to explore some of the ETs referenced by Mr. Hamden.

Mr. Hamden’s ET #1: Pleiadians

There are many references to “channelings” of Pleiadians. For instance,

[The Pleiadian Network: New Channelings from the Pleiadians](#)

According to former MUFON Director of Brevard County, Florida, Joseph Jordan and UFO Researcher and Ordained Minister, David Ruffino’s PowerPoint presentation at the 2008 Roswell UFO Conference, the “Pleiadian” address for our alien friends is new, and it differs from testimonies made in the 1950’s:

In the 1950’s and early 1960’s their [alien] message: They’re from planets within our solar system.

From 1970’s on -human spacecraft visit the planets in our solar system –[and we] find no life – [and] conditions on other planets [are] found to be hostile to life.

From 1970’s on –their story changes – [the aliens] claim their origins are from Orion, Pleiades, Sirius and on and on.....

Mr. Hamden’s ET #2: Zetas

There is a website called [ZetaTalk](#) which allegedly is channeled information from Zeta "Grey's".

In these two references (Pleiadians and Zetas), are we talking about physical communication between extraterrestrial beings, or are these “channelings” necessarily spiritual in nature? (That is not to say spiritual beings cannot take on physicality and form. We will explore this topic further in a later section.)

I would say by definition, channelings are spiritual communications. We saw within the Scriptures that channeling or invocation of spirits (“witchcraft”) is against the law and strictly forbidden by Scripture.

Mr. Hamden’s ET #3: Anunnaki

The "king of the Anunnaki", Enlil is the storm/wind god. The Encyclopedia Britannica says:

(Akkadian), Sumerian Enlil, Mesopotamian god of the atmosphere and a member of the triad of gods completed by Anu (Sumerian An) and Ea (Enki). Enlil meant 'Lord Wind'- both the hurricane and the gentle winds of spring were thought of as the breath issuing from his mouth, and eventually as his word or command [cf. Christian "logos" (John 1:1)]. He was sometimes called Lord of the Air.

Although An was the highest god in the Sumerian pantheon, Enlil had a more important role: he embodied energy and force but not authority. Enlil's cult centre was Nippur. Enlil was also the god of agriculture: the Myth of the Creation of the Hoe describes how he separated heaven and earth to make room for seeds to grow. He then invented the hoe and broke the hard crust of earth; men sprang forth from the hole. Another myth relates Enlil's rape of his consort Ninlil (Akkadian Belit), a grain goddess, and his subsequent banishment to the underworld. This myth reflects the agricultural cycle of fertilization, ripening and winter inactivity.

So all three contacts of Mr. Hamden appear not to be extra-terrestrial in nature, but rather spiritual. This kind of worship goes way back; it is as ancient as the creation of man. But didn't we evolve? Or perhaps we were created by aliens? We will explore our origins in the next section.

D: Origin of Life: From Where Did We Come?

Some [abductees] are enlightened with information that they are extraterrestrial beings that have been created by the ETs in human form in order to experience life on planet Earth. They were born to biological parents from their own genetically modified DNA. The ET's life force entered the human baby prior to birth. I know that some of this seems farfetched, especially to readers that embrace Western scientific materialism. But the reports are many. (AAF pg. 191 – emphasis mine)

Abductee "Jennie" discussing her ETs: There is no reason to fear. I need to learn that they are doing no harm. I am part of them. Before I was born they inserted a tiny fragment of themselves into me. (AAF pg. 158)

This "enlightened" information from extraterrestrials is of course, in direct defiance of Scripture which is clear that man's creator is God Himself:

And the Lord God formed man of the dust of the ground, and breathed into his nostrils the breath of life; and man became a living being. (Genesis 2: 7)

So God created man in His own image; in the image of God He created him; male and female He created them. (Genesis 1:27)

Knowledge of man's origin can be found throughout Scripture, as when King David of ancient Israel, ancestor of Israel's Messiah, worshipped his God:

*You made all the delicate, inner parts of my body
and knit me together in my mother's womb.
Thank you for making me so wonderfully complex!
Your workmanship is marvelous—how well I know it.
You watched me as I was being formed in utter seclusion,
as I was woven together in the dark of the womb.
You saw me before I was born.
Every day of my life was recorded in your book.
Every moment was laid out*

before a single day had passed.

How precious are your thoughts about me, O God.

They cannot be numbered!

I can't even count them;

they outnumber the grains of sand!

And when I wake up,

you are still with me! (Psalm 139:13-18)

But according to modern science, man evolved without a Creator, right? Due to advances in biology, cosmology, geology, paleontology etc., many scientists have voiced their concerns that Darwinian Evolution may not be sufficient to explain the whole story. For instance, DNA appears to be a highly intelligent code which inspired Bill Gates to make an interesting comparison, "DNA is like a computer program but far, far more advanced than any software ever created." In the fossil record, scientists have discovered a "Cambrian Explosion" of animal life. It suggests a very quick "explosion" of life; a full plethora of diverse animal phyla or body plans were fully formed in a geologic "instant" of time. This seems to contradict a gradual evolutionary process of life. Paleontologists still have not found the critical transitional forms of fossil remains which would reveal evidence for evolution, if it were true. Darwin had his own doubts due to the lack of transitional fossils found within the fossil record. However, Darwin anticipated that subsequent generations would find the transitional forms, thus validating his theory. We are still waiting – and not for lack of trying. For more information, I suggest Stephen C. Meyer's very informative book about the Cambrian Explosion entitled *Darwin's Doubt*. Additionally, our understanding of the "Big Bang" itself has now revealed what the Scriptures have always taught: all matter, time and energy "began" from nothing; the universe had a beginning.

But who wrote the program of all living things? Who was responsible for the "explosion" of animal life in the fossil record? And who stood outside of time and space to create the universe from nothing? While many scientists recognize intelligence, some have looked elsewhere for the intelligent designer of life. For instance, popular scientist Stephen Hawking as well as Francis Crick, co-discoverer of the DNA structure, have proposed panspermia as the possible intelligence behind the origin of life. Panspermia alleges that life was seeded on the earth from outer space. Interestingly, the notion of panspermia is one "belief" or "faith" system that both scientist and atheist can agree. Popular atheist spokesman Richard Dawkins, famous for his book *The God Delusion* responded in the following way when asked if Intelligent Design could be possible for the existence of life:

Well, it could come about in the following way. It could be that at some earlier time, somewhere in the universe, a civilization evolved, probably by some kind of Darwinian means, probably to a very high level of technology, and designed a form of life that they seeded onto perhaps this planet. Um, now that is a possibility, and an intriguing possibility. And I suppose it's possible that you might find evidence for that if you look at the details of biochemistry, molecular biology, you might find a signature of some sort of designer.

Stein (as Narrator): So Professor Dawkins was not against Intelligent Design, just certain types of designers *such as God*. (EXO pg. 204)

This idea of panspermia or the “Alien Gospel” as noted author, LA Marzulli refers to it, will be discussed further because it is very important, but first I would like to address the other major topic within the “Alternatives” section in AAF, specifically the comments made from various sources within the Catholic church.

The idea of human DNA coming from outer space or “panspermia” is not limited to the “many reports” of ET testimony. From scientists to atheist philosophers, this alternative creation story has been propagated within the marketplace of ideas.

In my previous section, “The Roman Catholic Church – Perspectives” we have already seen atheist and philosopher, Richard Dawkins’ view of life’s origins, namely that life was seeded on earth by intelligent extraterrestrials. But is there any scientific basis for such a view?

It turns out that some of the brightest minds in science are also entertaining the alien gospel. Francis Crick, co-discoverer of the double-helix DNA structure proposed a theory called *Directed Panspermia* with co-author Leslie Orgel:

It now seems unlikely that extraterrestrial living organisms could have reached the earth either as spores driven by the radiation pressure from another star or as living organisms imbedded in a meteorite. As an alternative to these nineteenth-century mechanisms, we have considered Directed Panspermia, the theory that organisms were deliberately transmitted to the earth by intelligent beings on another planet.... We draw attention to the kinds of evidence that might throw additional light on the topic. (Directed Panspermia Pg. 341)

The possibility that terrestrial life derives from the deliberate activity of an extraterrestrial society has often been considered in science fiction and more or less light-heartedly in a number of scientific papers.... Here we wish to examine a very specific form of Directed Panspermia. Could life have started on Earth as a result of infection by microorganisms sent here deliberately by a technological society on another planet, by means of a special long-range unmanned spaceship? To show that this is not totally implausible we shall use the theorem of detailed cosmic reversibility ; if we are capable of infecting an as yet lifeless extrasolar planet, then, given that the time was available, another technological society might well have infected our planet when it was still lifeless. (PAN pp. 342-43)

As a result of our ancestors following the serpent’s word, God declared an ancient prophecy which foretold the coming of the “seed” of the woman or Messiah:

So the Lord God said to the serpent: “*Because you have done this [deceived the woman, Eve], you are cursed more than all cattle, and more than every beast of the field; on your belly you shall go, and you*

shall eat dust all the days of your life. And I will put enmity between you and the woman, and between your seed and her Seed; He shall bruise your head, and you shall bruise His heel.” (Genesis 3:14-15)

This is interesting of course for two reasons. First, we know that “seed” comes from the man, not the woman. So in this prophecy, God foreshadows His own seed given by the Holy Spirit to Mary, the mother of Jesus. But secondly, the verse indicates that the serpent which is identified elsewhere as Satan, the great deceiver – also has “seed”! We know that Jesus told the unrepentant Pharisees “*You are of your father the devil, and the desires of your father you want to do.*” (John 8:44) So does that statement relegate the “seed” of the serpent as being metaphorical in nature, as in the Pharisees are only metaphorically the “seed” of the serpent? Certainly the Lord implies that men are metaphorically the sons of Satan when they refuse to repent of their sins, and receive His way of salvation. However, is it possible that the serpent also has *physical* seed? In the section “The Alien Agenda”, we will explore this idea further.

To a born-again Christian, the report from ETs, as well as Dawkins and Crick is not farfetched, in fact it is anticipated. In describing the end of the age, the apostle Paul writes:

For the mystery of lawlessness is already at work....The coming of the lawless one is according to the working of Satan, with all power, signs, and lying wonders, and with all unrighteous deception among those who perish, because they did not receive the love of the truth, that they might be saved. And for this reason God will send them strong delusion, that they should believe the lie, that they all may be condemned who did not believe the truth but had pleasure in unrighteousness. (2 Thessalonians 2: 7-12)

But how do we know that the “mystery of lawlessness” Paul refers to in Thessalonians is related to aliens? The short answer is that we don’t. These truths are up for interpretation. However, the best way to interpret the Scriptures is to use the Scripture itself. In the next section, we will explore this question further.

E: Who are the Aliens?

He [alien abductor] did something to my ovaries....He put something into my [Denise, abductee] abdomen and said that...It’s almost like I was impregnated, but I wouldn’t be the incubator....He just said that this is for you to carry but not to incubate for long...and that’s all. (AAF pg. 62-63)

Once, after what she [Denise, abductee] thought was an abduction experience, she tested positive on a pregnancy test. She lived in horrific fear of pregnancy, due to a past illness and being told she could not carry a fetus to term ever again. Then sometime during the first trimester, she awoke to find she was no longer pregnant. The baby had simply disappeared. Her womb was empty of all signs, and there had been no bleeding – no sign of a spontaneous abortion. (AAF pg. 108)

Beginning in the mid-to late 1980s, “missing fetus syndrome” emerged in UFO abduction literature and was hotly debated among researchers. (AAF pg. 178)

There, floating within these clear objects, were beings. Some were almost the size of human newborns. They appeared to be somewhat human in shape with differences in skin color, number of fingers and shape of eyes, with little or no hair.

We [Denise, abductee and her alien escort] next moved to smaller but similar vials. Then, in amazement, I knew as I approached the vial closest to me – this is the baby I had somehow “lost” the first time, the missing pregnancy. I felt a connection to the being with the artificial womb. There was a quickening, a sudden stirring in the fluid. I dropped my eyes downward just in time to see the eyes flicker, then open slightly....I knew in my heart this was my child, no matter where or how it was conceived. (AAF pg. 114)

I entitled this section “The Alien Gospel”, a phrase which noted author LA Marzulli coined to describe the “new” alien message which will in its fullness, become an alternative way of salvation for its adherents. Gospel literally means “good news”. So the alien gospel is the supposed good news of the enlightened ones to the less developed inhabitants of the earth.

Why are the aliens trying to procreate with human women?

1. The Days of Noah

Consider what Jesus said to His followers when they asked him about the end of the age:

When the Son of Man returns, it will be like it was in Noah’s day. In those days before the flood, the people were enjoying banquets and parties and weddings right up to the time Noah entered his boat. People didn’t realize what was going to happen until the flood came and swept them all away. That is the way it will be when the Son of Man comes. (Matthew 24: 37-39)

To fully understand what Jesus told his disciples, one must study intently what were the conditions during Noah’s day. The Bible records:

There were giants on the earth in those days, and also afterward, when the sons of God came in to the daughters of men and they bore children to them. Those were the mighty men who were of old, men of renown. (Genesis 6:4)

The “sons of God” in this context refers to fallen angels. So the offspring of the fallen angels and the daughters of men produced giants. Could this occurrence in Noah’s day be a literal manifestation of the “seed” of the serpent foretold by God in the Garden of Eden?

LA Marzulli has authored many books and other resources; for over two decades he has been active in eschatological study, research and investigation. Marzulli’s apt nick-name for the Judeo-Christian Bible is “The Guidebook to the Supernatural”. Marzulli was into New Age as a young man, specifically his interest was Hindu meditation. Marzulli followed many gurus who led him in the development of the ‘third eye’, and many other occultic practices. However, when LA Marzulli found the Prince of Peace, there was no turning back; he found what he had always been searching for in Jesus Christ. In his recent book entitled *The Cosmic Chess Match*, Marzulli advances a very interesting possibility for the motivation of Satan and his angelic followers:

I believe that the purpose of the incursion of the fallen angels, and what was behind their nefarious plan, was to contaminate the DNA of the human race and by doing so negate the prophecy of the seed of the woman, or the promise of the Messiah that was given shortly after the fall in the garden. (CCM pg. 29)

So what does all that mean to this generation? What do the giants of Genesis have to do with us? Remember that Jesus said, in the 'last days' it will be as were the days of Noah. Could we be in the Biblical "last days"?

End-time studies or eschatology is a vast topic in itself, but suffice it to the following statement by noted author, prophecy teacher and researcher Grant Jeffrey:

The prophecies in the Bible outline very clearly a series of events that will signal the final conflict of history. These incredible events will lead to the culmination of God's great plan, the hope of the coming Messiah and the establishing of His kingdom on the Earth.

Among those prophesied events, the most prominent was the rebirth of the nation of Israel....Wave after wave of immigrants endured the perils of enemy territory, persecution, extortion, and government opposition as they battled their way to their ancestral home. (MES pp. 7-8)

The Bible has many prophecies that Israel would be scattered to the four corners of the earth, and just as many which prophesied their return. For instance:

"Hear the word of the Lord, O nations, and declare it in the isles afar off, and say, 'He who scattered Israel will gather him, and keep him as a shepherd does his flock.'" (Jeremiah 31:10)

'Thus says the Lord God: "I will gather you from the peoples, assemble you from the countries where you have been scattered, and I will give you the land of Israel.'" (Ezekiel 11:17)

Jeffrey explains further:

God claims that the ability to predict and fulfill prophecy is a unique attribute to His nature as the Lord of Hosts: *"For I am God, and there is no other; I am God, and there is none like Me, declaring the end from the beginning, and from ancient times things that are not yet done, saying, 'My counsel shall stand, and I will do all My pleasure,'" (Isaiah 46: 9-10)* In this passage, the prophet Isaiah declares that not only does God foreknow future events, He also declares them and then brings them to pass.

The Lord Jesus told His listeners that all of God's prophecy as recorded in His Word would ultimately be fulfilled: *"For assuredly, I say to you, till heaven and earth pass away, one jot or one tittle will by no means pass from the law till all is fulfilled."* (Matthew 5:18) (MES pg. 12)

So if one studies the 8,352 verses of prophetic material in Scripture (which comprises 27% of the entire Bible), he will gain an appreciation for the events that have already been fulfilled, especially in relationship to the Messiah coming to earth as a suffering servant or High Priest. Jesus fulfilled scores of prophecies which predicted where He would be born, where He would preach, who would betray him and for how much silver, as well as the purpose of his death at the hand of sinful men, to name only a few.

Similarly, the coming of Messiah in the “end of days” is subject matter for many specific prophecies, including Jesus’ warning that He would return during times that would look comparable to the days of Noah. And as Grant Jeffrey pointed out, a major sign-post to the end times would be the return of Jewish exiles from every country to which the Lord had scattered them. Isaiah prophesied Israel’s unique way in which she would be reborn: *“Who has heard such a thing? Who has seen such things? Shall the earth be made to give birth in one day? Or shall a nation be born at once? For as soon as Zion was in labor, she gave birth to her children.”* (Isaiah 66:8) Our generation indeed saw the dramatic fulfillment of this prophecy on May 14, 1948.

So if our generation finds itself within these prophesied “end of days”, could the alien manifestation somehow be connected with Jesus’ Noahic comparison? This idea will be discussed further in the next section.

Let’s look at a very interesting non-cannonical book called the *Book of Enoch*; it was not included in the accepted Biblical canon of books, however it was quoted by Jude in the New Testament:

“In the seventh (generation) from Adam Enoch also prophesied these things, saying: ‘Behold, the Lord came with his holy myriads, to execute judgment on all, and to convict all the ungodly of all their ungodly deeds which they have committed in such an ungodly way, and of all the harsh things which ungodly sinners spoke against him’.” (Jude 14-15) as well as Enoch 1:9.

For a Biblical book to quote the *Book of Enoch*, it necessarily implies that its writer considered the *Book of Enoch* legitimate. Many other writings of Enoch agree in principle, if not word for word, with Scriptural doctrine and teachings. So what does Enoch have to tell us about the days of Noah? It turns out, quite a bit, as Enoch was grandfather to Noah.

God commanded Enoch:

Fear not, Enoch...go, say to the Watchers of heaven [fallen angels]...wherefore have ye left the high, holy and eternal heaven and lain with women, and defiled yourselves with the daughters of men and taken to yourselves wives, and done like the children of earth and begotten giants (as your) sons. And though ye were holy, spiritual, living the eternal life, you have defiled yourselves with the blood of women, and have begotten (children) with the blood of flesh and as the children of men have lusted after flesh and blood as those do who die and perish....And now, the giants who are produced from the spirits and flesh, shall be called evil spirits upon the earth, and on the earth shall be their

dwelling....Because they are born from men and from the holy Watchers is their beginning and primal origin; evil spirits shall they be called. (BOE pp. 13-14)

So given Marzulli's theory that Satan and by extension, the fallen angels wish to "contaminate the DNA of the human race", consider what some of your Experiences have testified:

Audrey [Abductee] asked why they [ETs] had put the machine on her neck. They said that they were altering or activating her DNA and doing something pertaining somehow to enlightenment. (AAF pg. 212)

She [Jennie, abductee] had acquired new knowledge. She somehow "knew" that these beings were not genetically compatible with humans, but were able to splice their DNA onto a human chromosome in order to create a human form that possessed the characteristics that they found desirable. (AAF pg. 177)

"They communicate to me [Jennie, abductee] that I am performing an important function for them. It is helping them to understand more about us. And they need to take my genetic material." She cries out as if in pain....(AAF pg. 157)

We have seen how the message of the extraterrestrials includes the claim of being man's Creator (even if they sometimes acknowledge that they are not God). We also see that the *modus operandi* of alien abductions is to take or alter DNA. We will next explore the "implant" phenomena as well as the gynecological aspects of alien abduction in an attempt to discover more about the agenda of these enigmatic creatures.

R.A. Gilbert who translated the Book of Enoch sums up the reality when he explained the various parts of The Book of Enoch:

It begins with an apocalyptic prophecy about the "Great Judgment".... The next section contains the most famous element of the text: the legend of the two hundred Watchers. These were the highest ranks of angels, but they had descended to Earth, taught forbidden knowledge to mankind, and mated illicitly with human women. Their offspring were the Giants (Nephilim) from whose souls issued demons. Enoch attempts, without success, to intercede on behalf of the fallen angels, but his plea is rejected and he is shown their future fate. (BOE pp. xxv-xxvi)

We have seen that the aliens have taken credit for God's creation, but do they really have an "alien gospel" or a message that contains a counterfeit gospel? Again let us consider thoughts from the Vatican. Guy Consolmagno, Vatican Astronomer, has authored a book entitled *Intelligent Life in the Universe: Catholic Belief and the Search for Extraterrestrial Intelligent Life*. In it, Consolmagno suggests that contemporary societies will "look to The Aliens to be the Saviours of humankind". (EXO pg. 17)

To Audrey, the aliens "said that they were altering or activating her DNA". What the aliens do not share however, is that by changing the DNA of their victims, the human is no longer human; they can potentially become a hybrid, a Nephilim. Did this already happen to Audrey and others around the world who have received alien implants? I don't believe so, because the Bible describes those who

“take” the mark – not those who are given the mark against their will. Also, the Bible describes that no man may buy or sell without the mark – so clearly we are not there yet. But eventually every person will be presented with the mark of the beast, and LA Marzulli has suggested that it will be similar to modern alien implants which “alter” its victims DNA to the point of no return.

I believe LA Marzulli was correct in his understanding of the alien motivation to procreate with women; they intend to corrupt the human race so that there will be nobody to “save” when the Lord comes back; this event is known as Christ’s “Second Coming”. I believe that is a very accurate insight. He also gives an interesting additional motivation: to build an army that fights Messiah as He returns to establish his kingdom for a thousand years.

2. Alien “Soldiers”

All along this hallway were Greys. And something in my [Denise, abductee] head said those are soldiers. (AAF pg. 53)

There are other smaller entities with huge eyes lining the hallway. I [Denise, abductee] think “soldiers” but have no idea where that [thought] came from....I figure if I made an attempt to run away, they would be there to stop me so I don’t test the theory. (AAF pg. 111)

What flashed across her [Jennie, abductee] mind was the memory of her husband’s defensive stance at the bedroom door and a group of intruders [ETs] who, with the precision of a well-drilled team of military officers, laid his limp, immobile body down on the bed. (AAF pg. 132)

In the days of Noah, the “giants” or Nephilim were created from the union of human woman and fallen angel. For those who find it hard to believe in the existence of “giants”, consider that Jewish Historian Flavius Josephus recorded “that the bones of these creatures [giants] were openly on display in Jerusalem at the time of his writing, which was thousands of years later!” (CCM pg. 92)

LA Marzulli noted that the giants always “happened” to show up at the same location where God planned good for His people, Israel. For instance Marzulli rhetorically asks:

Is it coincidence that when the spies are sent into the [Promised] land they encounter the same entities that we see in Genesis 6 [Nephilim: offspring from “sons of God” and daughters of men]? I think not, and would submit to you that the presence of the fallen angels creating these unholy hybrids, or Nephilim, is once again a deliberate attempt by the Fallen One to thwart the plans of the Most High God. (CCM pg. 92)

So given that the last days will also be similar to the days of Noah, could it be that the aliens are creating offspring to war with the Messiah during His second coming?

Why are the nations so angry?

Why do they waste their time with futile plans?

The kings of the earth prepare for battle;

the rulers plot together

*against the Lord
and against his Anointed One [Messiah].
“Let us break their chains,” they cry,
“and free ourselves from slavery to God.”*

*But the one who rules in heaven laughs.
The Lord scoffs at them.
Then in anger he rebukes them,
terrifying them with his fierce fury.
For the Lord declares, “I have placed my chosen king on the throne
in Jerusalem, on my holy mountain.” (Psalm 2: 1-6)*

Will the neo-Nephilim or alien-human offspring gather along with those who plot against the Messiah, and/or even instigate the plot itself? Will they for instance, gather in “Armageddon” or the valley of Megiddo prior to the final battle between Messiah and Israel’s enemies who attempt to wipe her off the face of the earth? I believe this will be the case.

F: What is their Purpose?

1. Alien Device Implants

I [Denise, abductee] felt like he [alien abductor] stapled me or something....It [UFO] brought me back....When I lay down I felt my head, and it was bleeding. It was split open. (AAF pg.74)

83 percent (40 of 48) [of the experiencer group] have awakened with unexplained marks on their bodies, such as burns, puncture wounds, bruises, and evidence of a bloody nose. (AAF pg. 124)

53 percent (21 of 40) of the experiencer group believe that they can feel an alien implant in their body. (AAF pg. 125)

Jennie: I’m thinking of a time that Tom (Jennie’s husband) came home the next day and we were bathing Aiden (son) and I started coughing and coughing and something flew out of my nose. It was the strangest little seed and it had a little wire-like thing coming out of each end of it....And Tom said, “Let me see that.” And he took it and he flushed it down the toilet....He destroyed the evidence.

While the evidence for Jennie’s implant was destroyed by her husband, many other abductees have successfully had their implants removed by California Surgeon, Dr. Roger Leir. LA Marzulli has created the “Watchers” DVD series, and in them, he interviews Leir who is shown holding an implant.

In our DVD, *Watchers: UFOs are Real, Burgeoning and Not Going Away*, we filmed surgeon Dr. Roger Leir who has gained world-wide notoriety for removing 16 implants from people. He has had the objects tested by some of the most prestigious labs in the USA.

Leir described the implants as being comprised of carbon nanotechnology, also having an outside layer which prevents the body from rejecting the device. He stated that the sophistication of the implant is far beyond current human technology.

Marzulli had various insights into the alien agenda with regard to possible intentions behind implant devices. He suggested that the devices will:

- 1) become the “mark of the beast” referred to in Scripture

He [“Beast” or Anti-Christ] causes all, both small and great, rich and poor, free and slave, to receive a mark on their right hand or on their foreheads, and that no one may buy or sell except one who has the mark or the name of the beast, or the number of his name. Here is wisdom. Let him who has understanding calculate the number of the beast, for it is the number of a man: His number is 666. (Revelation 13: 16-18)

Marzulli points out that for one to receive the mark of the beast, “there is no second chance” (CCM pg. 268):

Then a third angel followed them, saying with a loud voice, “If anyone worships the beast and his image, and receives his mark on his forehead or on his hand, he himself shall also drink of the wine of the wrath of God, which is poured out full strength into the cup of His indignation. He shall be tormented with fire and brimstone in the presence of the holy angels and in the presence of the Lamb. And the smoke of their torment ascends forever and ever; and they have no rest day or night, who worship the beast and his image, and whoever receives the mark of his name.” (Revelation 14: 9-11)

Note that a “loathsome sore” occurs for those who take the mark of the beast:

Then I heard a loud voice from the temple saying to the seven angels, “Go and pour out the bowls of the wrath of God on the earth.” So the first went and poured out his bowl upon the earth, and a foul and loathsome sore came upon the men who had the mark of the beast and those who worshiped his image. (Revelation 16: 1-2)

- 2) causes the host to have a longer life span

What if this chip that is produced by the fallen angels does the unthinkable in that it extends human life, disease-free, for let’s say 500 years, give or take. Please recall that we are warned by Yashua/Jesus *that it will be like the days of Noah*. I want to call your attention again to the fact that in Noah’s day there was extended life. For instance Methusaleh lived to be 969 years of age! (CCM pg. 269)

In those days men will seek death and will not find it; they will desire to die, and death will flee from them. (Revelation 9:6)

So Marzulli foresees the following scenario: “When ET shows up in mile-wide craft, they will gain our trust by offering a chip that will extend our lifespan free of disease.” (CCM pg. 270)

3) change the host’s DNA making him part-alien (fallen angel)

I asked Dr. Leir what he thought the purpose of the implants were and he informed me that his best guess was that they were changing the DNA of the person in whom they were inserted. He doesn’t believe they are tracking devices. (CCM pg. 266)

So in summary, Marzulli explains:

I believe this implant would change the DNA and, because the source of that chip or implant would be from the Fallen One, it would alter humans, making them literally *modern-day Nephilim*. If this scenario proves to be true it would give us a model that is inclusive of all the prophecies that I stated previously. It would account the long life span, as in the days of Noah, the new way of buying, selling, or trading, the ability of the body to repair itself and, thus, not being able to die, the sores that may break out on the body because of the implant and finally, the judgment of those who have the mark being thrown into the lake of fire as they are no longer human, as their DNA has been changed, but have become Nephilim. (CCM pp. 270-71)

2. Alien Integration

David Jacobs has amassed nearly a half century studying the UFO phenomenon. In an interview with LA Marzulli, Jacobs said that when he began his research, he was excited about the possibility of discovering a new species. (Watchers 7) However, the more Jacobs would study, interview abductees, and research the phenomenon, the more unsettled he would become. At first his abductee interviews contained the same kind of gynecological and reproductive focus as your research in AAF (missing fetus syndrome, fetuses in containers of liquid etc.), however according to Jacobs, the aliens have recently progressed to what he has coined “Alien Integration”:

“Abductees were shown pictures of people in groups and asked to pick out the hybrids from the humans. When they were unable to do so, they heard a voice telling them that this was a wonderful thing. Everyone looked alike. Soon everyone would be together here...A change was going to happen and it was going to be just wonderful. When I began to understand that this meant an integration program into human society, I must admit that I became fearful of the phenomenon. (AIN pg. 14)

Jacobs become so fearful and unsettled, he penned another book on the subject, patently titled *The Threat: Revealing the Secret Alien Agenda*.

In *The Threat*, Jacobs takes his readers through many abduction testimonials, similar to Alien Abduction Files. He reveals evidence that the aliens have progressed in what he believes to be their purpose or agenda. Jacobs shows that the aliens have gone from gynecological tampering, to hybrid (alien/human) fetuses, then onto hybrid adolescents and finally to hybrid beings integrating into human society. In Jacobs' view, the alien agenda has been premeditated and calculated and will not stop until they are fully integrated:

As if to reaffirm their plan, when aliens talk about the future, they do not say... 'Soon we will be gone. Our program is at an end. Thank you for your help. Once we leave no one will be sure we were ever here'. This is *never* stated. The future for the aliens and hybrids is always a future on Earth where they will be integrated with humans. They offer no other possibility.

There is yet another very disturbing aspect to the aliens' view of the future. When they refer to the "humans," they are talking about abductees. The future of, and with nonabductees is rarely the subject of much conversation....The evidence seems to suggest that the future will be played out primarily with aliens, hybrids, and abductees....The new order will be insectlike aliens in control, followed by other aliens, hybrids, abductees, and, finally, nonabductees. (THR pg. 253)

Jacobs predicts that the insect alien will be in control? Isn't that a similar being to what Thomas Reed had attempted to convey in his 1969 drawing illustrated in *Alien Abduction Files*? Could Jacobs unwittingly be speaking prophetically when he predicts that the "new order will be insectlike aliens in control"? Consider this prophecy made by John in the Biblical book of Revelation which is slated to take place on the earth prior to the return of Jesus Christ, the Messiah:

The shape of the locusts was like horses prepared for battle. On their heads were crowns of something like gold, and their faces were like the faces of men. They had hair like women's hair, and their teeth were like lions' teeth. And they had breastplates like breastplates of iron, and the sound of their wings was like the sound of chariots with many horses running into battle. They had tails like scorpions, and there were stings in their tails. Their power was to hurt men five months. And they had as king over them the angel of the bottomless pit, whose name in Hebrew is Abaddon, but in Greek he has the name Apollyon. One woe is past. Behold, still two more woes are coming after these things. (Revelation 9: 7-12)

How could the Apostle John have predicted a world that will be taken over by insectoid creatures – locusts who were "like horses" and whose wings were "like the sound of chariots"? Could it be that the God of all creation told the end from the beginning, and revealed this information – to comfort his followers, and to warn all others? Indeed, the Lord is making an entreaty to you, calling you to Himself before all of these things come upon the earth. Man has fallen into sin and judgement, yet the God of

all creation has made a way of reconciliation and salvation through the death, burial and resurrection of His son. When will you receive this free gift that cost Jesus Christ his very life? When will you be reconciled to the living God?

St. Paul describes the kingdom of darkness as currently being “in heavenly places”:

For we do not wrestle against flesh and blood, but against principalities, against powers, against the rulers of the darkness of this age, against spiritual hosts of wickedness in the heavenly places. (Ephesians 6:12)

The Bible prophecies a future time when the devil will be cast out of “heavenly places”, and will come down to the earth:

Therefore rejoice, O heavens, and you who dwell in them! Woe to the inhabitants of the earth and the sea! For the devil has come down to you, having great wrath, because he knows that he has a short time. (Revelation 12:12)

For Christians, we are comforted because while ‘all hell’ literally breaks loose on earth, we know that the final result will be the return of Jesus, the “Prince of Peace” Himself.

And there will be signs in the sun, in the moon, and in the stars; and on the earth distress of nations, with perplexity, the sea and the waves roaring; men’s hearts failing them from fear and the expectation of those things which are coming on the earth, for the powers of the heavens will be shaken. Then they will see the Son of Man [Jesus] coming in a cloud with power and great glory. (Luke 21:25-27)

While Jacobs does not advocate religion at all, he may even be an atheist, yet he had this to say, “I have become somewhat apocalyptic in view of its [alien’s] purpose. I have come to the conclusion that human civilization may be in for a rapid, and perhaps disastrous, change not of our design and I am all the more uncomfortable because the reason for this change is the *least* acceptable to society – alien integration.... I have come to view the alien abduction phenomenon and its purpose as an asteroid hurtling toward Earth – discovered too late for intervention. We can track its progress and yet be utterly incapable of preventing the collision. As much as I want to be optimistic, I find little to fuel hope for the future. (THR pg. 256)

F: Forbidden Knowledge

The scientist has stated, in a series of technical papers, that Paul [Medium, Paul Hamden] has channeled scientifically verifiable information far beyond his educational level and the scope of his knowledge. (AAF pg. 225)

Often they [ETs] impart special knowledge to the “experiencers”. (AAF pg. 192)

She [Jennie, abductee] has, in the not too distant past, recovered from the trauma directly related to her abduction experiences. Today her quest for knowledge pertaining to the alien agenda is shared with several experiencers from around the world. All have acquired similar knowledge and view their experiences as non-threatening and friendly.

Although her non-human visitors continue, from time to time, to insert themselves into her life, she is grateful for the knowledge that she is acquiring.

I [Kathleen Marden, Author AAF] asked Denise what effect alien abduction has had upon her life. She replied: ... Following each one, [I] have learned so much about places I truly know exist, met beings who are so much more advanced than we are and may know at least some of the secrets of the Universe, and [I] would not give any of it back if I could. (AAF pg. 127)

Its dedicated members [Mutual UFO Network] volunteer their free time to investigate UFO sightings and abductions, and collect the data for use by researchers worldwide. Their goal is to promote research on UFOs to discover the true nature of the phenomenon, with an eye toward scientific breakthroughs, improving life on our planet, and educating the public on the UFO phenomenon and its potential impact on society. (AAF pg. 140)

It is understandable to be enamored with the knowledge of the “universe” – vast and otherworldly. But are the entities who give this “special knowledge” good in their core nature? Before walking through the Biblical insights into this question, consider the views of UFO researcher Jacques Vallée, who is not a Christian yet he discerns the danger of automatically yielding to ET entities:

I believe that UFOs are physically real. They represent a fantastic technology controlled by an unknown form of consciousness. But I also believe that it would be dangerous to jump to premature conclusions about their origin and nature, because the phenomenon serves as the vehicle for images that can be manipulated to promote belief systems tending to the long-term transformation of human society. I have tried to identify some of the manipulators and to highlight their activities, which range from apparently harmless hoaxes such as the false professor George Adamski’s meetings with Venusian spacemen to bloody expeditions that have littered the American landscape with the carcasses of mutilated animals. I have found disturbing evidence of dangerous sectarian activities linked to totalitarian philosophies. The ease with which journalists and even scientists can be seduced into indiscriminate promotion of such deceptions is staggering. In the context of an academic attitude that rejects any open investigation of paranormal phenomena, such fantastical conversions must be expected. For me, that is only one more reason for an independent thinker to remain vigilant against false ideas and simplistic political notions planted by those I have called the Messengers of Deception. (EXO pg. 227)

I intend to show that the aliens and their gospel, and their promise of enlightenment is in fact not new, rather it is the same alternative, forbidden knowledge that the serpent of old offered to Eve in the garden of Eden declaring, *“You won’t die!...God knows that your eyes will be opened as soon as you eat it [forbidden fruit], and you will be like God, knowing both good and evil.”* (Genesis 3:4)

We will look deeper into the essence of UFOs, and the physicality of ETs in the next section, but first I want to explore why the alien gospel can be interpreted as part of the Apostle Paul’s “mystery of lawlessness”.

1. Ancient Lessons

Could it be that our thirst for knowledge is the very same hook that baited our American ancestors as well as other people groups around the world? Is it possible that 21st century America is going the same way as Genesis chapter 6, as well as many diverse cultures around the world?

Hindu Religion

In the ancient *Mahabharata* and other Sanskrit texts, “gods came to earth, took human wives and had children who often also displayed supernatural abilities like those of their fathers. (SQ Aliens pg 75)

Japanese Religion

According to the *Kiwi* (the stories that delineate the Japanese religion)...Susano [a god] was tossed from heaven. Upon falling from heaven, Susano met a grieving couple who were fearful their daughter would be sacrificed to an eight-tail dragon. The god Susano agreed to save the daughter, provided she would marry him afterward. (ALI pg. 76)

Aztec Religion

Quetzalcoatl or “Feathered Serpent” is the son of two pagan gods.

Zapotec Religion

Human sacrifice was practiced by rulers who claimed to have long genealogies that connected them to supernatural parents. (ALI pg. 68)

Mayan Religion

“The Mayan’s tradition held that their kings were half god/half human; these rulers are occasionally pictured as having six fingers and six toes.” (ALI pg. 66) Interestingly the Bible also describes Nephilim or half fallen angel/half human offspring appearing as giants with six fingers and six toes.

Korean Religion

The Koreans believe that a heavenly king, Hwanin, sent his son Hwanung to marry an Earth woman. She gave birth to Tan-gun Wanggom who brought the primitive tribes in the region together into the Korean kingdom. (ALI pp. 76-77)

G: Occult Connection?

88 percent [43 of 49] of the respondents [abductees who completed the “Marden-Stoner Commonalities Among Abduction Experiencers” questionnaire] answered in the affirmative, stating that they have witnessed... [paranormal] activity in their homes. This does not mean that UFO abductions are an event related to spirits angels, demons, astrals,

or interdimensional beings. Most experiencers are convinced of its physicality. They can feel the non-human entity's skin and observe its body. They can describe the craft's internal environment and equipment in a physical sense. (AAF, pg. 200)

The assumption made in AAF is that because alien beings and UFO structures have "physicality", it necessarily rules out demonic origin for aliens and UFOs. I intend to show that this pivotal conclusion is a flawed assumption and it contains a false premise.

Before delving into the physicality of fallen angels, it would be helpful to know what the Bible says about God's holy angels. The fallen angels were also holy and blameless prior to their rebellion, so the physicality of holy angels is likely similar to that of the fallen angels.

1. Holy Angels

We've probably all heard of the word "angel". Perhaps it elicits different images for different people. Some see angels as little baby beings with wings like various artistic renditions. But who are they really, and what are their purpose? The Bible says that angels are "*ministering spirits sent forth to minister for those who will inherit salvation.*" (Hebrews 1:14)

So can these spirit-beings also become physical? We know that angels were physically seen by men. There is actually Biblical basis for the well-known TV series *Touched by an Angel*.

Consider the following men and women of God who were visited by heavenly beings.

Elijah:

Then as he [Elijah] lay and slept under a broom tree, suddenly an angel touched him, and said to him, "Arise and eat." Then he looked, and there by his head was a cake baked on coals, and a jar of water. So he ate and drank, and lay down again. (1 Kings 19: 5-6)

Daniel:

I [Daniel] turned my face toward the ground and became speechless. And suddenly, one having the likeness of the sons of men touched my lips; then I opened my mouth and spoke, saying to him who stood before me, "My lord, because of the vision my sorrows have overwhelmed me, and I have retained no strength. For how can this servant of my lord talk with you, my lord? As for me, no strength remains in me now, nor is any breath left in me."

Then again, the one having the likeness of a man touched me and strengthened me. And he said, "O man greatly beloved, fear not! Peace be to you; be strong, yes, be strong!"

So when he spoke to me I was strengthened, and said, "Let my lord speak, for you have strengthened me." (Daniel 10: 15b-19)

Mary:

Now in the sixth month the angel Gabriel was sent by God to a city of Galilee named Nazareth, to a virgin betrothed to a man whose name was Joseph, of the house of David. The virgin's name was Mary. And having come in, the angel said to her, "Rejoice, highly favored one, the Lord is with you; blessed are you among women!"

But when she saw him, she was troubled at his saying, and considered what manner of greeting this was. Then the angel said to her, "Do not be afraid, Mary, for you have found favor with God. (Luke 1: 26-30)

The Apostle Paul exhorts Jesus' followers, *"Do not forget to entertain strangers, for by so doing some have unwittingly entertained angels. (Hebrews 13:2)*

So logic dictates that if God's angels can appear to men with physicality insofar as to even "touch" them, the fallen angels can appear to men as well. But do they?

Stephen Quayle who has studied eschatology and alien phenomena for over forty years, often references demons as "shape-shifters". But is this Biblically accurate? Can demons or fallen angels take on physicality?

Jude alluded to this idea in the New Testament:

And angels who did not keep their own domain, but abandoned their proper abode, He has kept in eternal bonds under darkness for the judgment of the great day, just as Sodom and Gomorrah and the cities around them, since they in the same way as these indulged in gross immorality and went after strange flesh, are exhibited as an example in undergoing the punishment of eternal fire. (Jude 1: 5-7)

a.) UFO Structures

[Kathleen] Can you describe the craft [UFO]? What did the craft look like?

I [Denise] see the bottom and the middle rim holds it together. There are two parts and one rotates clockwise and the other rotates counterclockwise [sic]. The whole center section is the entity that operates the craft. It is the center disk. There are a lot of lights. They are white, and there are some around the edges and on the bottom. [AAF pg. 67]

I [Kathleen] had spoken with several experiencers that have memories of the craft as a living entity. One experiencer stated, "Biological material is used deep within the energy system of the craft." Another wrote to me in a private communication, "These craft are living entities, much like a bacteria. They live breathe function and create. They are grown from what was initially a hybrid framework. The craft are generic, genetically modified structures. Not all craft have individual operators, but there are certain parts of their DNA replicated." Still another wrote, "The craft seems to have its own intelligence. It can sense its surroundings. [AAF pg. 68]

Now it came to pass in the thirtieth year, in the fourth month, on the fifth day of the month, as I was among the captives by the River Chebar, that the heavens were opened and I saw visions of God. On the fifth day of the month, which was in the fifth year of King Jehoiachin's captivity, the word of the Lord came expressly to Ezekiel the priest, the son of Buzi, in the land of the Chaldeans by the River Chebar; and the hand of the Lord was upon him there. Then I looked, and behold, a whirlwind was coming out of the north, a great cloud with raging fire engulfing itself; and brightness was all around it and radiating out of its midst like the color of amber, out of the midst of the fire.... Also from within it came the likeness of four living creatures. Now as I looked at the living creatures, behold, a wheel was on the earth beside each living creature with its four faces. The appearance of the wheels and their workings was like the color of beryl, and all four had the same likeness. The appearance of their workings was, as it were, a wheel in the middle of a wheel. When they moved, they went toward any one of four directions; they did not turn aside when they went. As for their rims, they were so high they were awesome; and their rims were full of eyes, all around the four of them. When the living creatures went, the wheels went beside them; and when the living creatures were lifted up from the earth, the wheels were lifted up. Wherever the spirit wanted to go, they went, because there the spirit went; and the wheels were lifted together with them, for the spirit of the living creatures was in the wheels. When those went, these went; when those stood, these stood; and when those were lifted up from the earth, the wheels were lifted up together with them, for the spirit of the living creatures was in the wheels. (Ezekiel 1: 1-21 – Emphasis mine)

Could Ezekiel's description "*and their rims were full of eyes*" be similar to that from Denise, "There are a lot of lights. They are white, and there are some around the edges and on the bottom."? Perhaps the experiencers understanding of the UFO transporter being 'alive' could be similar to the prophet Ezekiel who said, "for the spirit of the living creatures was in the wheels". Could this be so?

There is nothing new under the sun. When Ezekiel described his vision, I believe the Lord allowed the prophet to experience the holy angelic realm. Could it be that the fallen angelic realm has its own similar technology?

2. The Greys

My inquiries to Audrey [abductee] gave me an additional clue. At a young age, a neighborhood woman had drawn the twins into her occult world. Both stated that they were taken by the dark forces when they were younger and have struggled to bring themselves into the light. (AAF pg. 209-10)

When I asked Audrey to present her most convincing evidence of extraterrestrial visitation to me, she spoke of an incident that occurred on January 3, 2007....She described it as...like a magnetic sensation – like I'm attracting something. It's hard to explain but I've been feeling that since I was a child when the Grey ones come. (AAF pg. 210)

Another time she [Audrey] felt she'd been raped in her bedroom by a good-looking man that suddenly turned into a green lizard-like reptile resembling Sleestak from the show "Land of the Lost"The evil sounding voice [of the reptilian ET] reported by Audrey caused me to wonder if somehow a demonic, rather than extraterrestrial, presence had entered her home. (AAF pg. 209)

Notice that Audrey experiences the regular "grey" aliens as well as the reptilian 'demonic-like' aliens. Is it merely a coincidence that the supposed grey extraterrestrials also happened to choose the same woman who had also experienced the evil reptilian demon-kind of ET? Is this a case of aliens having different natures, or could this be a 'good cop / bad cop' scenario?

In *Hostage to the Devil*, Malachi Martin writes the story of a man named Jamsie who suffered from schizophrenia-like symptoms for many years. Jamsie heard voices, and he eventually saw a physical entity called "Uncle Ponto" which would be with him until it was eventually cast out by "Father Mark", a Catholic Priest. Martin describes "Uncle Ponto" when Jamsie saw it for the first time:

Then something caught his (Jamsie) eye in the rearview mirror. It was a face....He glanced again in the mirror: the large, bulbous eyes were still looking at him....The face had a nose, ears, mouth, cheeks, a funny chin much too narrow for the rest of his face, a kind of high-domed forehead ending in a somewhat pointed head. The skin was dark as if from long exposure to sunlight....The face was certainly alive—the eyes glinted with meaning, even laughingly....As he turned slowly into the driveway to his garage, he heard a voice, chiding and familiar, in tones he would expect a eunuch to have: "Oh! For Pete's sake, Jamsie! Stop acting the fool. We've been together for years. Don't tell me you don't know me." (HTD pg. 273)

Uncle Ponto had a funny, and almost kind and playful demeanor such as the time he "was moving his left hand as though pitching a ball, and with each gesture he seemed to throw a word, a phrase, or a whole sentence into the sky where it remained for a while and then danced away over the horizon.

"WELCOME TO JAMSIE MY FRIEND!" ran one message. "GREATEST BLOW-OUT FOR THE MIND!" was another. "PONTO! JAMSIE! PALS! REJOICE! PASADENA HERE WE COME!"

Uncle Ponto even helped Jamsie at work as a Broadcaster for a Los Angeles radio station; Jamsie "had developed a broadcasting style all his own, 'and it was good for business'. Jamsie was not slow to recognize that he had Ponto to thank for much of that. Uncle Ponto would gyrate around him in the studio saying irrelevant things only Jamsie could hear. He would produce statistics, figures, facts, and data which Jamsie would automatically incorporate into his patter of broadcasting, keeping up an incredible stream of banter. It was bright and amusing, a cherry-breery-bee kind of prattle full of various irrelevancies about this, that, and the other, all strung together with 'but' and 'whereas' and 'lest I forget it'.... This style became his signature, well known and valued, on the air. For the first few months in San Francisco, therefore, Jamsie secretly valued Ponto's presence". (HTD pg. 280)

After some time however, Uncle Ponto began to continually make the same request, "Jamsie, let's get married." Uncle Ponto started to appear at any hour of night or day – unlike before when he at least wouldn't disturb Jamsie's night-time hours. And Ponto would harp on the 'marriage' issue incessantly,

chanting 'let me in, let me in' making Jamsie weary to the point of suicidal thoughts. Then one day, Jamsie heard *many* voices:

Very late one particular evening in December of 1963, after having had his nerves jangled in this way by Ponto for too long, Jamsie could hardly believe it when Ponto was finally quiet for a while. Jamsie soaked up the badly needed tranquility.

But rather soon he began to hear a new sound. He listened intently. He could hear Ponto's voice clearly, but it seemed to be caught up in a babel of other voices similar to Ponto's.

He could not tell what was being said. There was a lot of laughter and many exclamations. But the whole thing reminded him of how sometimes he used to listen to the radio in his home of the 1930s and get nothing but a rising and falling stream of static together with indistinct and far-off voices.

As Jamsie strained to hear, there was a pause and silence. Then Ponto's mincing voice from the kitchen: "Jamsie, would you mind if some of my associates and family joined us? After all, we are going to get married, aren't we? And soon, eh?"

The babel of voices started again and seemed to be approaching the door of his living room. Jamsie froze for a second; then, seized by a blind, rushing panic, he stood up and dashed out the door, got into his car, and sped as fast as he could to the Golden Gate Bridge. His mind was numb, but his emotions were in turmoil. He felt cold, unwanted, persecuted, desperate. He could not take any more of it. He wanted out. He stopped in the middle of the bridge... (HTD pg. 287)

Eventually Jamsie remembered Father Mark, and Uncle Ponto was subsequently exorcised from Jamsie.

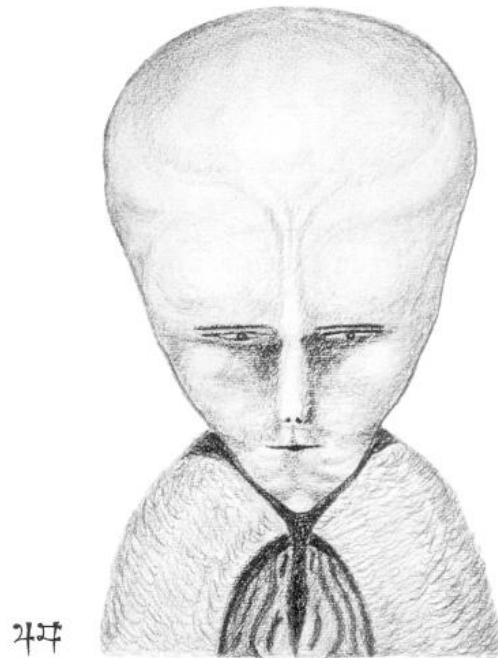
It was the young assistant who described the change in Jamsie. There was no more hint of struggle. A great calm filled Jamsie's features. Mark's voice still boomed, even though the noise had died away. Mark was repeating again the two words: "Jesus! Mercy!" The young priest knew that Jamsie was free at last. He unbuckled the straps that held Jamsie down on the cot. "Mark!" Jamsie shouted to the exorcist as he rose up from the cot. "Father Mark! I'm free!" (HTD pg. 320)

Could it be that Uncle Ponto played a 'good cop' role while his many friends who were laughing with him in Jamsie's kitchen were the 'bad cop' entities who also wanted to invade Jamsie's soul? Could this be similar to the alien "greys" and the reptilian 'race' of aliens? Are these aliens extraterrestrial, or are they similar to the fairies, goblins, djinn, leprechauns, forest spirits, pixies, fey, brownies, sprites, nymphs, boggarts, hobs, gnomes, elves, trolls, dwarfs, incubi and succubi in various cultures and ages throughout history?

The popularly-called "Greys" are also called "Zetas" due to the belief of their location of origin. It is believed Zetas or Greys come from the Zeta Reticuli star system which is roughly 35 light years away.

But is that true – did these aliens really come from the Zeta Reticuli star system? Consider an image which originally came from Aleister Crowley, a very well-known Satanist from England in the turn of the 20th century. As Crowley channelled an entity, he was inspired to draw its image, whom he called

“Lam”. In 1919, Crowley included the portrait of Lam in his *Dead Souls* exhibition held in Greenwich Village, New York.



THE WAY

LAM is the Tibetan word for Way or Path, and LAMA is He who Goeth, the specific title of the Gods of Egypt, the Treader of the Path, in Buddhistic phraseology. Its numerical value is 77, the number of this book.

Crowley contacted or invoked “Lam” and purportedly created portals or openings in the fabric of space/time for these entities to enter our world. Kenneth Grant is accepted to be Crowley’s successor. He and two others have since been instrumental in ever-widening these portals: Jet Propulsion Laboratory founder and rocket fuel scientist, Jack Parsons, and Scientology and Dianetics founder L. Ron Hubbard.

Is it merely coincidence that Crowley’s “Lam” resembles modern alien Grays? Crowley channeled “Lam” in 1919, a quarter-century before the signature features of the modern “alien” became known and recognized. It appears that “Lam” also looks very similar to many of the Experiencers’ drawings in AAF. Could there be a connection? Are these aliens really extra-terrestrial, or as you surmised briefly in AAF, could they instead be “inter-dimensional”? Could your experiencers be victims of the demonic realm due to these opened portals? Given Crowley’s known Satanic background, the resemblance of his channeled entity Lam to modern alien Grays should spawn questions of alien origin.

We have seen the drawing of “Lam” by Church of Satan founder Alister Crowley who in 1919 drew a perfect “Grey” ET – 25 years before the ET profile was established. And we know that Crowley used

satanic methods to channel his “Lam”. I would suggest that while the “Greys” seem harmless as compared to the reptilian aliens, they all have the same boss.

Of course there are other ‘types’ of ETs which do not look like Crowley’s “Lam”, for instance “insectoids” and “reptilians” and others. They deserve attention, and I will cover that phenomenon further in a later section.

Scripture makes clear that angels can shape-shift and become human-looking. So logic dictates that fallen angels can also shape-shift. They have deceived before, and they are deceiving once again.

Jaque Vallee pg. 113 of *Messengers of Deception: UFO Contacts and Cults*

Jaque Vallee has studied UFO phenomenon since the 1960s and his extensive work in the field has caused him to make a startling deduction. “Jaque Vallee has gone on the record stating that he believes these entities are interdimensional rather than extraterrestrial.” (AI pg. 31)

Vallee’s reasoning is that he sees too much congruency between the occult world and the alien phenomenon.

In particular, the stark warning I issued in connection with the HIM cult (“It only costs your life!”) appears as unfortunately prophetic in light of the March 1997 collective suicide of Heaven’s Gate, as the group became known. The mass killings of the adepts of the Order of the Solar Temple in Canada, France and Switzerland in 1994 illustrated the dangerous form of mind control and the simulation of extraterrestrial contact I first described here in connection with the “Adventures of a Grand Master.” The cattle mutilations phenomenon remains unsolved. (MOD pg. v)

Vallee, who has spent over four decades studying ET phenomenon, mentioned “cattle mutilations” in the same context as alien research. But do aliens have anything to do with animal mutilations? In LA Marzulli’s book “Alien Interviews”, Marzulli writes extensively about this type of activity:

The Cattle mutilation phenomena has been going on for decades. Linda Moulton Howe has been investigating reports of cattle, which have their sexual organs, eyes, tongues or anus cored out with surgical precision....The carcasses are left and there are no footprints or tire marks near it. It has been reported that even scavengers like coyotes won’t go near them – and those critters will eat anything! The phenomena continues to this day, although not reported by the mainstream press. Even some ranchers have decided not to report when they find a carcass. (AI pg 46)

It does seem telling that aliens repeatedly have interest in the reproductive organs of their victims. Is it a coincidence that reproductive organs from cattle have also been a hot commodity for the last fifty years? Are aliens responsible for the grievous offense of cattle mutilation? Does occultism sometimes play a cameo role in this melodrama? Consider the account of Ranchers Chuck [Charlie] and Stan Mosser as interviewed by LA Marzulli:

L.A. What was missing from the animal?

Charlie: The udder and eyeball and the anus/vaginal area.

L.A. Were there any tracks near it?...

Charlie: ...There were no tracks, not even her own. Usually, when an animal dies, the other animals will walk around it out of curiosity...but that wasn't the case with these....It was like she was gently lowered into position....

Stan: We lost 28 cows. They were all lost basically the same way, just different missing parts....

L.A. Did you see anything unusual that aroused your suspicions?

Stan: I later on did. I can remember when me and the boys were out there after the mutilations started happening and I asked them, "Do you feel like there's somebody staring at us?" We had all had that feeling when we went there for several days. So a few days later, I walked up to a lava outcropping/ledge about one-half mile from the well. The edge of an area called The Devil's Garden. I found a cave, and in there were signs that people had been there recently. I found some occult paraphernalia, weird things and scraps. I can't recall everything I found, but I do recall a pentagram woven from grass/straw, and several pieces of cloth, about three to four inches in diameter.

L.A.: What do you think caused this?

Stan: I think it's something our own country did. Military or something.

Charlie: UFOs? Cults? I disagree with my dad here...Due to the occult trinkets, I would have to go with the cults. (AI pgs 46-50)

LA Marzulli summarizes, "Something is happening on the farms and ranches, and not only in the U.S. but in other countries as well. I found the interview with Chuck and his Dad to be unnerving. There are those in the UFO community that believe that the samples that are taken from the animals are used in genetic experiments. Abductees claim that they often see vats with hybrids floating in some kind of liquid. Is this what the cattle mutilation is for? There are those who have claimed to see cows being beamed up into the belly of a UFO. (AI pgs 52).

One can readily see the occult activity connected with cattle mutilation; but isn't it interesting that cattle have allegedly been seen "beamed up into the belly of" UFOs? That would seem to be reveal a direct connection to alien phenomenon. So, in summary, we can see that at least this once, the occult activity summoned and gave authority to UFOs who then carry out the morbid cattle mutilations.

Jaque Vallee believes that the alien agenda is socially and politically transforming in its ideology:

Fantastic economic theories, including the belief that a "world economy" can be created overnight, and that democracy should be abolished in favor of Utopian systems, usually dictatorial in their outlook. Such ideas are present, in one form or another, in the statements of the organized UFO cults and sects that are described here.... (MOD pg. 113)

Using the techniques of oral history, based on personal observations and interviews that were transcribed and edited, I have compiled and interpreted profiles of the leaders of this new subculture.

In this search I have met Helen, a young woman who believes that she was teleported aboard a flying saucer and emerged with a formula for cosmic energy. In Paris I visited the leaders of an occult organization who meet regularly with extraterrestrials who are preparing social revolution. In California I have attended meetings of the Human Individual Metamorphosis as they were recruiting passengers for the next saucer trip to "the other level." In Spain I have interviewed Jacques Bordas, who stated that he had supplied food to extraterrestrials in the Pyrenees in 1951 and was still in contact with them. I came back to the States and met a woman psychic who argued about Atlantis and the elimination of our money system. I interviewed a would-be political leader, a member of the John Birch Society, who was trying to put a contactee into the White House.

The ideas of all these people had certain important themes in common. Underneath the trivia, the verbiage, the platitudes, there were powerful symbols and powerful social images: universal peace, the exploration of space, a single world economy, and the elimination of money. I traced some of these ideas to active occult organizations that are operating just below the threshold of public notice. (MOD pg. 60)

In August 1975, a friend had called my attention to a one-page announcement that was posted in the windows of stores in Palo Alto, California, and on the campus of Stanford University. UFOs? was written in bold red letters across the page. The statement - entitled simply What's Up? - began with the observation that our environment was changing and that a human catastrophe seemed imminent: not only were people drinking more than usual and committing suicide by the thousands, the flyer said, but the weather was changing, famines were widespread, and even volcanoes were acting up!

The strange statement continued with the sensational claim that, in preparation for a better world, some people had formed a new group and left everything behind: they had quit their jobs and left their families "to follow what they would previously have considered as bizarre studies or practices." They were seeking real truth. The text was signed by flying-saucer believers who called themselves H.I.M., or Human Individual Metamorphosis. The announcement continued:

Some, who by most standards would have been considered stable . . . are attempting to completely rise above their human nature (get this!)* under the direction of individuals who are members of a kingdom above human who have come in at close range to the Earth to help. They compare this period of overcoming their human nature to the metamorphic process of a caterpillar becoming a butterfly. (MOD pp. 75-76)

* Material in parentheses is part of the original, not my (nor Vallee's) comment.

Stunning isn't it, that the "aliens" would compare hybridization as the "metamorphic process of a caterpillar becoming a butterfly". What (and who) are we going to believe?

3. Abductions Short-Circuited?

LA Marzulli had a very interesting interview with a man named Joe Jordan. I looked up Jordan's website, and their home page says this:

Joe Jordan is the President and co-founder of CE4 Research Group, an Alien Abduction investigation and research team based out of Cocoa, Florida. Joe has been a Mutual UFO

Network Field Investigator since 1992. He has shared his research findings from his Alien Abduction investigations through many radio shows, newspaper and magazine articles, DVD's, and lectures. His research findings on Alien Abductions have been written about in twelve different authored books over the past decade.

He has spoken during six Roswell UFO Festivals in Roswell, New Mexico, including the 60th Anniversary Conference in 2007. He was also honored to host the Roswell UFO Festival Conference for the city of Roswell in 2008. CE4 Research Group has been the Investigative arm of AlienResistance.org, a clearing house website covering the Biblical view on the UFO phenomenon. Seeing that there seemed to be a spiritual nature to the Alien Abduction experience, they posed the question, "Are Christians being abducted by Aliens"? (<http://www.alienresistance.org/ce4.htm>)

Marzulli interviewed Jordan and here are some very interesting comments:

L.A. Has anyone ever stopped an abduction?

J.J.: Now to the crux of my research findings. In 1996, I interviewed a gentleman who shared his atypical abduction experience. During his experience, which was terrifying, he was able to stop the experience abruptly. Being a Christian, he called out in the name and authority of Jesus Christ. He immediately woke up startled in his bed. I had not heard of anyone being able to stop an abduction experience before. Puzzled by what we had, I called some of the top abduction researchers in the field to get advice. After sharing the story with them on the phone, they each asked if we could talk off the record. That means I can tell you what they said but not who said it. Each one stated that they had come across similar cases in their research. My question was why we had never read or heard about such cases if they had come across them. Their answer was at first that they didn't know what to make of it. I would have been fine with that answer had they not followed it with another. The other answer was they did not want to go there because it might affect their credibility in the realm. So silence was what they decided on. I have a problem with this. Isn't this what a cover-up is? Government cover-up like we hear so much about, we are getting it from the very researchers that we are relying on for the truth....

After ten years of documenting cases, we have worked with well over three hundred testimonies of stopping the experience in the name and authority of Jesus Christ. I have posted over seventy-five of them on my website, www.ce4research.com. It wasn't long before we had people asking us if we could help them stop their experiences. Learning from those we had worked with already, we showed them how it was possible. And we were able to help them also....

This name Jesus Christ is not a magic word. This comes only with a personal relationship to Him. He knows your heart.

A very important aspect to this experience is that these entities come against your will. But this Jesus Christ offers you to come to Him on your free will. Who do you chose if you have a choice?

I have found a very anti-Christian attitude in the UFO realm; why is that? It seems O.K. to be of any other belief system or none at all. But say you're a Christian and your research is not valid....Please look at the evidence. The evidence of the case testimonies says the abduction experience can be stopped. Not only once, but it can be terminated from your life completely. We have been able to help others; that's a repeatable event, the only one in the UFO realm.

L.A.: Your closing thoughts?

J.J.: ...My concern is helping people who are hurting from this experience. If you need help, you can talk to us through our counseling website, www.aaccoa.org, Alien Abduction Crisis Centers of America....The talk that I did in Roswell this year with my partner Dave Ruffino will be available shortly. It is already being termed the 2008 Roswell Incident. We stunned the UFO community with living evidence on stage. It is available through the www.ce4research.com website. It upsets most all of the other researchers to hear this presentation of the evidence. Please look at it yourself.

My final thoughts: Resistance is not futile. (AI pgs 33-36)

Joe Jordan and the CE4 Research Group is the organization I referenced in my introduction. If you have not heard about this organization already, I believe it will be of great interest to you and many of the Experiencers you referenced in your book. The group that J.J. mentioned took part in a very interesting MUFON 2008 Conference which occurred in Roswell, New Mexico. Due to its non-traditional content, the conference has been given the name "2008 Roswell Incident" by some of its attendees. The speakers were Joe Jordan (MUFON Director in FL) and David Ruffino (a Messianic Jewish Believer in Jesus). The focus of this MUFON conference was to explore how and why many abductees have been able to successfully stop the alien abduction experience by calling out in the name of Jesus Christ. I highly recommend your viewing this presentation – the authors surely did their homework. This presentation is the culmination of fifteen years research by Joe Jordan while he was acting Director of MUFON for Brevard County, Florida.

H: Nature of Alien Abductions

Her [Denise's] emotional response to her abductions is consistent with that of other abduction experiencers' responses. She stated that she felt confused and disoriented....She felt anger knowing that her life was in the entities' hands and out of her control. She knew that they didn't have to return her to her natural environment if they did not wish to. [AAF pg. 124]

She [Denise] and 69 percent (22 of 32) of the female participants have experienced gynecological problems that they suspect are related to their abduction experiences. 33 percent (3 of 9) of the female control group reported experiencing gynecological problems. [AAF pg. 125]

She [Jennie] awoke one summer morning with a haunting memory from the night before. She thought that it had been a dream, but she will never forget the pain from her physical injuries. Her burning genitals wept clear fluid and her sacroiliac was too painful to tolerate sitting on a hard chair at the breakfast table....Periodically throughout her adult life, she awoke with vague memories of contact with non-human entities and painful bruises in her genital-rectal area. [AAF pg. 165]

She [Jennie] and 83 percent (40 of 48) have awakened with unexplained marks on their bodies. Jennie has discovered burns, bruises consistent with finger marks, scoop marks, and rectal bruises on her body. [AAF pg. 199]

"What's wrong?" She [Jennie] felt Doug's tender hand upon her shoulder....Then, pushing her back far enough to look into her eyes, his perplexed voice spoke. "Why are you crying?"

"They took the kids," Jennie choked, barely audible. "There's blood on everyone's pillow." [AAF pg. 137]

Also, we must consider Jennie's children's behavior....It didn't take long for Jennie to find kitchen knives and hatchets under their mattresses. It was out of character for two well-behaved, studious youngsters. They resided in a stable home with loving and supportive parents in a sleepy, secure community. This sudden shift in their behavior is perplexing but consistent with behavioral changes reported by others who have experienced alien abduction. [AAF pgs 161-62]

CFIDS, a debilitating illness, is highly prevalent among alien abduction experiencers....The disorder is characterized by debilitating fatigue that is not improved by bed rest, and may be exacerbated by physical or mental activity. Its symptoms include profound exhaustion, problems with concentration and short-term memory, flu-like symptoms, fever, night sweats, tender lymph nodes, sore throat, and headache. Word-finding problems, reading retention difficulties, ambulation difficulty due to balance problems, lightheadedness and mental foggy are all symptoms of CFIDS. Medical researchers have noted immune, neurological, and endocrine abnormalities in CFIDS sufferers. Among sufferers, 25 percent are bedridden and 50 percent cannot work during flare-ups. [AAF 139-40]

Is the alien abduction an exclusively 21st century phenomenon? After all, science has illumined us to the vast reaches of space where untold entities could have arisen over eons of time, right? Consider this. What are the stories, tales and legends of the following entities, and what do they have to do with the alien phenomenon in our day?

Likely some of these names you recognized without effort. These are names of entities coined from all over the world, whose behavior happen to be similar to the demons of Scripture, *and* to the “aliens” of our day.

So if the so-called “aliens” are indeed demons, could the modus operandi of aliens make sense from a Biblical perspective? The Bible says that Satan (and his fallen-angel followers by extension) comes “*only to steal and kill and destroy.*” (John 10:10)

While Satan would want to deprive mankind of choice, and eliminate his freewill, Jesus has come that all mankind “*might have life, and that they might have it more abundantly.*”

Satan wants abduction Experiencers to think that they have no choice but to submit to a lifelong battle with CFIDS and unwanted experiences. But the God of all life gives us free choice.

Then the LORD said to Cain, "Why are you angry? Why is your face downcast? If you do what is right, will you not be accepted? But if you do not do what is right, sin is crouching at your door; it desires to have you, but you must rule over it. (Genesis 4:6-7)

The Lord continually encourages us, but in the end, the choice is ours. Just as Cain chose to murder his brother, we can choose to listen to the urging of the One who loves us, or we can imitate the father of sin and lies.

Do you want to give yourself to one whose nature is full of cold, calculated, deceptive and destructive tendencies? Or do you want to give your heart to your very Creator, and follow the Way He has ordained: Jesus; the One who gave His life so you might be free? The love of Jesus is endless, and it is in His name that over 100 people became free from the bondage of alien abduction. I urge you, and pray earnestly that you would investigate why the name of Jesus has power over the 'alien' entities.

Therefore God also has highly exalted Him and given Him the name which is above every name, that at the name of Jesus every knee should bow, of those in heaven, and of those on earth, and of those under the earth, and that every tongue should confess that Jesus Christ is Lord, to the glory of God the Father.
(Philippians 2:9-11)

Conclusion

What is the bottom line – does it really matter what kind of world view one holds concerning the alien phenomena? Perhaps Jaque Vallee said it best when he exclaimed, "It only costs your life!" Indeed and I would add, it 'only' costs your eternal life. It is very important which worldview we hold going into the rest of this decade. I hope to have presented a helpful case from a Christian world view that you might consider while trying to make sense of the alien phenomenon experienced in *The Alien Abduction Files*. And my prayer is that you will want to continue researching UFO phenomena, keeping in mind a Biblical world view. And my greatest prayer is that you and all your readers will come to a saving knowledge of Jesus Christ – the One who is above all 'principalities and powers' which includes demons and inter-dimensional spirits who disguise themselves as 'aliens' or 'gods'.

Who is like the Lord?

*Among the gods there is none like you, Lord;
no deeds can compare with yours.*

*All the nations you have made
will come and worship before you, Lord;
